# IMPORTANT Mercy Co-worker Health Benefit Plan Changes for 2025

Effective **January 1, 2025**, the Mercy Coworker Benefit Plan will transition away from Anthem, our current benefit administrator, to United Healthcare (UMR) Optum as our plan administrator for medical and behavioral health services.

As a current Tier 1 provider/facility for the Mercy Employee Plan, we would like to continue to include you as a Tier 1 provider. No action is needed on your part <u>unless you are not currently a contracted Optum provider/facility.</u> The 2025 Mercy Employee benefit Plan Tier 1 provider reimbursement will be processed at your contracted Optum agreement reimbursement rates.

If you are not a contracted Optum provider/facility and wish to join that network for continued Mercy Employee Benefit Plan Tier 1 reimbursement, behavioral health doctors and therapists should go to www.providerexpress.com or call Optum for behavioral health inquiries at 877-614-0484 to apply.

- Essence does <u>NOT</u> require prior authorization for routine outpatient visits, including psych/neuro psych testing.
- Communication with the members PCP is extremely important. Please obtain authorization to release information to PCPs, particularly those taking medications, have unstable conditions, and those with co-morbid chronic medical conditions. Integrated care results in better overall health outcomes.
